Education Consultant Program Reports from October 15, 2024, to

December 10, 2024.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

#### Effective October 15, 2024:

 High Desert Medical College, Bakersfield, Vocational Nursing Program – Request Approved

The Program requested to admit a full-time class of 20 students to commence on November 18, 2024, with a graduation date of March 16, 2026. This replaces the class that graduates on November 6, 2024.

 Marian College, Los Angeles, Vocational Nursing Program – Requests Approved

The Program requested to admit a full-time class of 15 students to commence on October 30, 2024, with a graduation date of February 12, 2026. This replaces the class that graduates on October 23, 2024.

This Program further requested to admit a part-time class of 15 students to commence on December 5, 2024, with a graduation date of August 8, 2026. This replaces the class that graduates on November 23, 2024.

Unitek College, Concord, Vocational Nursing Program – Requests Approved

The Program requested to admit a class of 36 full-time evening students commencing on December 9, 2024, and scheduled to graduate on March 27, 2026. This is not a replacement class.

The Program further requested a change to increase the pattern of admission to include: Six 46-week full time day classes of 36 students per year, two 62-week full-time evening class per year, and three 75-week part-time evening/weekend classes of 36 students to replace graduating students only.

The Program further requested a curriculum revision from a part-time curriculum of 72 weeks to a revised part-time curriculum of 64 weeks. The Program will have four 16-week terms. The proposed curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 hours.

#### California Career Institute, Centinela, Vocational Nursing Program – Request Approved

The Program requested to admit a part-time class of 45 students to commence on November 19, 2024, with a graduation date of July 10, 2026, to replace the class that graduated on August 9, 2024. This will be the third class for the Program.

## Career Care Institute, Moreno Valley, Vocational Nursing Program – Request Approved

The Program requested to admit a full-time evening class of 30 students to commence on December 16, 2024, with a graduation date of April 16, 2026. This replaces the class that graduated October 16, 2024.

## • Clement Career College Vocational Nursing Program – Request Approved

The Program requested to admit a full-time class of 30 students to commence on November 4, 2024, with a graduation date of October 9, 2025. This is an additional class.

#### CNI College Vocational Nursing Program – Request Approved

The Program requested to admit a full-time class of 30 students to commence on November 5, 2024, that will graduate on December 7, 2025.

# Gurnick Academy of Medical Arts, Sacramento, Vocational Nursing Program – Requests Approved

The Program requested to admit class of 84 full-time students to commence on January 6, 2025, with a graduation date of December 19, 2025, to replace the class that graduates on January 31, 2025. Forty-two students will be in the day class and 42 students will be in the evening class.

The Program further requested a pattern of admission of a cohort of 84 students to be admitted each January and July. Forty-two students will be in a day class and 42 students will be in an evening class, replacing graduating students only, after all students on the previous curriculum have graduated.

# Pasadena City College Vocational Nursing Program – Request Approved

The Program requested a curriculum revision from full-time curriculum of 41 weeks to a revised full-time curriculum of 41 weeks. The proposed curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 hours.

#### Quest Nursing Education Center Vocational Nursing Program – Requests Approved

The Program requested to admit a part-time day class of 30 students to commence on November 13, 2024, with a graduation date of March 4, 2026, which will replace the class graduating on October 30, 2024.

The Program further requested to admit a part-time evening class of 15 students to commence on November 13, 2024, with a graduation date of March 4, 2026, which will replace the class graduating on October 30, 2024.
